Order Granting Motion for Leave to File Amicus Curiae Brief

[ECF No. 11]

8 Plaintiffs Lisa McAllister and Brandon Summers sue Clark County, Nevada, over a new
9 regulation that prevents people from stopping or standing on pedestrian bridges crossing the Las
10 Vegas Strip, contending that the ordinance violates the Americans with Disabilities Act (ADA),
11 is unconstitutionally vague, and offends the First Amendment’s free-speech protections.¹ They
12 move for a temporary-restraining order and preliminary injunction to halt enforcement of the
13 ordinance until this case is resolved.² For its part, Clark County moves to dismiss the case,
14 arguing that the ordinance withstands constitutional scrutiny and doesn’t violate the ADA.³

15 The Nevada Resorts Association now moves to file an amicus curiae brief “in support of
16 Clark County.”⁴ Plaintiffs don’t oppose, but they “request clarification regarding what filing by
17 [Clark County] the brief is in support of and an opportunity to respond to the proposed . . . brief
18 if [they] deem it necessary.”⁵ I construe the proposed amicus brief as supporting Clark County’s
19 opposition to plaintiffs’ TRO and PI motions—doing so best preserves the Association’s

1 immediate concerns with this lawsuit and prevents evidence external to the complaint from
2 permeating the motion-to-dismiss proceedings. With that limitation, I grant the Association's
3 motion for leave to file its amicus brief and give plaintiffs ten days to respond to that amicus
4 brief.

5 **Conclusion**

6 IT IS THEREFORE ORDERED that Nevada Resort Association's motion for leave to
7 file an amicus curiae brief, construed as a brief in opposition to the plaintiffs' motions for a
8 temporary-restraining order and preliminary injunction, [ECF No. 11] is GRANTED. The
9 Clerk of Court is directed to detach pages 9–52 of ECF No. 11 and docket that document
10 separately as a **Brief of Amicus Curiae**.

11 IT IS FURTHER ORDERED that **plaintiffs have until Monday, April 21, 2024, to file**
12 **a response to the amicus brief**. Replies will not be permitted.
