**STIPULATION AND ORDER TO  
EXTEND STAY FOR TWO WEEKS**

**(THIRD REQUEST)**

## 10 Respondent

18 Petitioner American Civil Liberties Union of Nevada (“ACLU”) and Respondent Las  
19 Vegas Metropolitan Police Department (“LVMPD”), stipulate to extend the current stay of this  
20 matter an additional four weeks to October 17, 2025.

21 The parties continue to actively engage in discussions to resolve this matter without further  
22 Court intervention. Since the Court entered the prior stay (Doc. 7), LVMPD believes that it has  
23 produced all documents responsive to ACLU's Petition for Writ of Mandamus. (Doc. 1). To  
24 preserve the Court's limited resources and facilitate a resolution agreeable to both parties, the

1 parties seek a stay of this matter until October 17, 2025. The additional time will allow ACLU to  
2 review the production, including the privilege log and supporting materials, and allow the parties  
3 sufficient time to meet and confer in good faith to address any outstanding issues or concerns. The  
4 parties also seek to continue the Status Check previously set by this Court from September 23,  
5 2025, to October 21, 2025.

6 This Stipulation is made in good faith and not for the purpose of delay.

7 **ORDER**

8 Accordingly, it is hereby ORDERED that this matter is STAYED to October 17, 2025;

9 It is further ORDERED that the STATUS CHECK currently set for September 23, 2025,  
10 is continued to October 21, 2025, at 9:00 A.M. for the parties to appear and advise the Court on  
11 the status of their negotiations and steps moving forward.

12 IT IS SO ORDERED.
