**STIPULATION AND ORDER TO  
EXTEND STAY FOR TWO WEEKS**

**(SIXTH REQUEST)**

Petitioner American Civil Liberties Union of Nevada (“ACLU”) and Respondent Las Vegas Metropolitan Police Department (“LVMPD”), stipulate to extend the current stay of this matter an additional two weeks to December 12, 2025.

The parties have resolved to dismiss this matter with prejudice with LVMPD agreeing to pay a negotiated amount of ACLU’s costs and attorneys’ fees. Once LVMPD provides a check for the negotiated amount to ACLU, the parties will submit a Stipulation and Order to dismiss the matter with prejudice. To preserve the Court’s limited resources, the parties seek a stay of this

1 matter until December 12, 2025. The additional time will allow LVMPD to deliver the check to  
2 ACLU. The parties also seek to continue the Status Check previously set by this Court from  
3 December 2, 2025, to December 16, 2025.

4 This Stipulation is made in good faith and not for the purpose of delay.

5 **ORDER**

6 Accordingly, it is hereby ORDERED that this matter is STAYED to December 12, 2025;

7 It is further ORDERED that the STATUS CHECK currently set for December 2, 2025, is  
8 continued to December 16, 2025, at 9:00 A.M. for the parties to appear and advise the Court on  
9 the status of their negotiations and steps moving forward.

10 IT IS SO ORDERED.
