IT IS HEREBY STIPULATED AND AGREED, by and between Respondent Las Vegas
Metropolitan Police Department (“LVMPD”) and Petitioner American Civil Liberties Union of
Nevada (“ACLU”), by and through their respective counsel, that all of ACLU’s Claims for Relief
in its Petition for Writ of Mandamus (Petition, Doc. 1) are hereby dismissed, with prejudice, with
LVMPD agreeing to pay a negotiated amount of ACLU’s costs and attorneys’ fees. This
stipulation applies only to the public records requests described within the Petition and does not
cover any public records requests not described therein.

The parties also stipulate and agree to vacate the December 16, 2025 Status Check previously set by this Court.

ORDER

Accordingly, it is hereby ORDERED that this matter is DISMISSED WITH PREJUDICE.

It is further ORDERED that the STATUS CHECK currently set for December 16, 2025, is VACATED.
